# Section I

## General Seasonal Camping Information

- 1. Communications:** The primary method of communication is email. If you do not provide an email address on your Seasonal Camping Agreement, you are opting out of timely notifications from the camp office. Fireside Resort does not use postal service mail for notices, invoices, or receipts.
- 2. Emergency Numbers:** Ambulance, Fire, Police dial 911.

If possible, notify the office and have someone go to the entrance to lead emergency responders back to the Campsite.
- 3. Lost & Found:** Located in the Campstore/office.
- 4. Mail/Packages:** Fireside Resort cannot accept responsibility for your packages or mail; these will be refused at time of delivery.  
Campers and registered guests are not tenants and may not claim Fireside Resort's address as a residence.
- 5. Site Boundaries:** Most boundaries are from electric pedestal to electric pedestal. Ask at the office for more details about specific site boundaries.
- 6. Registration Restrictions:** Campers must personally register for a camp site and may not register for other people. Sites are issued only to people twenty-one (21) years of age or older, who shall be responsible for the conduct of all people visiting the assigned campsite. ONLY the registered people (two adults and four dependent children, with the exception of larger families) are to use the seasonal campsite. The registered camper(s) is NOT permitted to rent a campsite to anyone or split the campsite with others.

# Section II

## Financial Obligations & Policies

- 1. Early Termination:** Fireside Resort Campground does not give refunds for early termination of your Seasonal Agreement. Management must be notified before removal if you wish to terminate this Agreement early.
- 2. Electric Meter Billing:** Electric is charged at a rate of \$0.17 per KW/Hr. Electric Meters are read at the beginning of each month. Payments are processed automatically by the office from a credit card on file. This charge will occur the first Sunday of each month. End of season billings will be emailed by October 19. No balances will be carried over into the new season.  
Rate subject to change. Electric charge rate is subject to change.
- 3. Golf Carts:** A golf cart \$25 registration sticker is required per golf cart. Registration stickers must be adhered to the front lower right of windshield or upper right front of cart body.
- 4. Mowing:** Sites must be mowed and trimmed once per week. Flower beds and plantings are always to be maintained. Gravel sprayed for weeds if necessary. Campers are responsible for providing their lawn care equipment; riding mowers/tractors cannot be used. A push mower is located by Campstore for use also. \$25/week for mowing, spraying, or trimming is

available, sign up at the office for this service. Sites that are not mowed once per week are subject to staff cutting them and your account being charged \$50 per mowing, trimming, or spraying in conjunction with your electric bill.

**5. Site Payments:** A **non-refundable** down payment of \$550 is required to secure your Campsite. This payment will be applied to your 2026 Seasonal Admission Rate. A \$100 discount will apply if full payment is made in cash before October 12, 2025. The remaining balance will be divided in half, first half due Dec. 14, 2025, and last half due Feb. 14, 2026. All past due payments will incur a \$50 fee, and may result in loss of site. A credit card form will need to be on file for electric, firewood, pump outs and store charges. A transaction fee of 3% will apply. If you wish to not have a card on file a \$100 deposit is required on account, and will be returned at the end of season, after all open invoices are paid.

**6. Winter Parking:** If you intend to leave your Camper on your Campsite over the winter, the parking fee of \$200 along with a \$550 non- refundable down payment are due no later than October 11, 2024. There will be no access to your camper during the winter season. If access is needed during off season, there will be a \$100 charge to open the gate. Contact the office for more details on Winter Parking. Do not enter without management permission, doing so is trespassing and will result in a \$200 charge. Exceptions can be made at owners discretion. Campers doing winter parking, an email with dates to check on your camper, will be emailed.

**7. Payment Types:** Down payments may be made with cash, check, or credit cards. Checks must be made payable to Fireside Resort. The balance of your seasonal site fees may be paid with cash or check. A 3% surcharge applies to credit card payments.

**8. Refunds/Transfer:** Season Camping Admission fees are non- refundable should you choose to depart earlier than October 11, 2026. Should you sell your camping unit during the season, the new owner has the option to sign a Seasonal Camping Agreement and use the site. Please see "Sale of RV/Camping Unit" for more details. A transfer fee of \$25 applies.

**9. Returning Next Season:** If you are planning to return for the 2026 season, we must have your signed Seasonal Camping Agreement and a non- refundable down payment of \$550 by October 12, 2025. This amount is applied toward your 2026 Seasonal Camping Admission Rate. Requests for new sites can be made at any time and are determined under the discretion of management. If you are leaving your RV/Camping Unit on your site for the winter, a non- refundable \$150 winter parking fee is also due by October 12, 2025. An invoice

for the remaining 2025 season balance will be sent by October 30, 2025. If you are not returning for the 2026 Season, your RV/Camping Unit and all other items must be removed from your site by 5:00pm on October 12, 2025. Winter parking is available only to those returning for 2026.

Campers who have not returned their signed **Seasonal Camping Agreement** and **down payment** by the deadline will forfeit their site. The forfeited site will then be made available to other prospective guests. Out of Agreement campers will be charged \$30/day for storage. Reasonable attempts shall be made by the Campground to contact the Camper and collect fees due. Any campers who are out of Agreement for a period of 60 days or more shall have their property remaining on the Campsite considered abandoned. The abandoned property is subject to towing and/or disposal by the Campground without further notice.

**10. Season Opening:** The Seasonal Campground opens April 17, 2026 with no early entry. Campers with outstanding balances will not have access to their site.

**11. Season Closing:** October 11, 2026, at 5:00pm. Plan to winterize before this date. The final account invoice will be charged on October 18, 2026. No balances will be carried over into the new season.

If you are not returning, please remove the camping unit and all personal effects by October 12, 2025, at 5:00pm. For each day over, a daily rate of \$40 will be charged.

**12. Sewer Fee Schedule:**

Honey Wagon service= \$7 per handle

Sign up in the hallway by restrooms.

Will be billed with your electric invoice.

Improper sewage discharge = \$200 and possible immediate ejection without refund.

Do not tow tanks through the grass, must stay on roadways.

**13. Firewood Pricing:** \$6 bundle, \$50 wood box, \$60 metal box; subject to change due to supply chain changes. Will be billed with your electric invoice.

**14. Sub-leasing:** Sub-leasing of your camping unit/campsite is not permitted. The campsite holder may not rent to a third party: a camping unit/campsite, associated with the current campsite. This includes letting someone stay at your camper/site when you are not present and for free.

**15. Substitutions:** Substituting any campers listed on your Agreement is strictly prohibited.

**16. Vacating your Site:** You are not permitted to remove your RV/Camping Unit from Fireside Resort Campground without first notifying the office. Outstanding balances must be paid in full. As a Seasonal Camper, you agree to pay your balance and any attorney fees or court costs (if applicable).

## Section III

### Access to the Campground

- 1. Activities:** You and your registered family members are encouraged to participate in activities and crafts planned by the recreation staff. Some projects and crafts may have a cost associated with them. There is a cost for visitors to participate. Supplies may be purchased at the Campstore with cash, Credit Card, or by using your account charge. Weekly Activity Schedules are available on our website, [WWW.FIRESIDERESORT.NET](http://WWW.FIRESIDERESORT.NET) under activities calendar. An adult must always accompany children under 13, do not drop them off at Campstore. Any children that are a continual distraction to the recreation staff because of their action, attitude, misbehavior, or lack of regard for the safety of themselves or others will be asked to leave the Campstore area.
- 2. Background Check Authorization:** Fireside Resort Campground is committed to providing a safe, family-friendly environment for its campers. Thus, all adults, ages 18+ applying for Seasonal campsites must consent to a criminal background check to be considered for admission to Fireside Resort Campground.
- 3. Day Use Visitors:** You or your children may have friends come over and stay the day. Adult registered seasonal campers must be present. They must register at the office as a visitor to gain access to the facilities. After 10pm, visitors on the premises and all unregistered visitors will be considered trespassers and will be required to leave. Must park in the asphalt parking lot.
- 4. Day Use Parking:** Daytime visitors are to park at the asphalt parking lot. The gravel lot is for campers only.
- 5. Overnight Visitors:** All overnight visitors must register at the office. \$10/person per night. You are allowed up to 8 people total at your Campsite, including the people already registered as seasonal campers. You are responsible for their behavior and any damages they may cause.
- 6. Speed Limit:** 5mph park-wide. See section VI for speeding violations. This includes golf carts.
- 7. Swimming Pond:** No Lifeguard on Duty. An adult must always accompany children under 14, do not drop them off. Do not bring food or drink into the pond area. Please leave with what you brought, sand toys, floaties, balls, etc. left in the pond area, become property of Fireside Resort. No smoking in the pond area.

**8. Fishing Pond:** Fishing is catch and release. No swimming in the fishing pond; no pets in the pond. No throwing rocks, food, or debris in the pond.

**9. Winter Access:** After October 12, 2025, the seasonal area is closed. There is no access between October 12, 2025 and April 17, 2026. There will be a \$100 fee to open the gate in the off season. Do not enter without management permission, doing so is trespassing and will result in a \$200 charge.

**10. Inclement Weather:** In the event of severe storms or other acts of nature, management will do its best to announce on the seasonal Facebook page. Fireside Resort will provide shelter in the camp store bathrooms. If an act of nature creates damages to your camper/site please contact your insurance provider.

## Section IV

### General Camping Policies

**1. Alcohol/Drugs:** Alcohol is permitted, must be 21 to consume. Public drunkenness may result in immediate termination of seasonal camping agreement. Drugs are strictly prohibited on Fireside property.

**2. Bathrooms:** Open 24 hours unless posted otherwise for cleaning. Please accompany children under eight years old. Contact the office if bathrooms need attention.

**3. Campfires:** Firewood is available in bundles and bulk. Please use a fire ring for your fire no bigger than 24". Never leave a campfire unattended. Do not burn pallets, trash, rubbish, leaves, building materials, or any other items that are not firewood. Do not place ashes into the dumpsters or roads. Ashes can be placed in black barrels by the maintenance building.

**4. Firewood:** Outside firewood is permitted. We sell wood by the bundle as well as in bulk from the office. Bulk firewood is available by order in the office. Do not stack firewood against trees. Up to 1 cord of wood may be kept at your site. Wood stored at your Campsite must be stacked on a rack or on gravel.

**5. Campsite:** You must maintain a clean and orderly campsite. If you need to store items at your site, please see Shed policy 4.24 for the appropriate size and style. A site improvement form will need to be approved before any shed is delivered or constructed. You may not store items (decks, tarps, and the like) under your Camping Unit. All personal property to be stored at your site must be contained inside a shed. Firewood is the only exception, up to a cord of wood may be stored outside. Management reserves the right to maintain any campsite it deems necessary at the cost of \$50 per man hour. If you wish to move campsites and need management help, it is \$50 per man hour. When moving sites, old site must be clean, free of debris and belongings.

**6. Chainsaws:** Chainsaws are prohibited.

**7. Clotheslines:** Strictly prohibited for the safety and aesthetics of Fireside Resort.

**8. Decorations:** Please keep decorations, signs, flags, and the like to a minimum. The use of nails and screws in trees is prohibited. Political signs and flags are prohibited.

**9. Landscaping:** You are welcome to landscape your site, but keep in mind that you are responsible for the upkeep of all flower beds and plantings as well as mowing and trimming. If the Campsite and flowerbeds become overgrown with weeds, dead leaves, or unsightly growth, Fireside Resort reserves the right to clear the area out and plant grass seed instead for a charge of \$30 per hour. All site improvements require pre-approval, please see Site Improvements form. Do not cut down or trim any trees, shrubs, or bushes without permission.

**10. Leaf Removal:** Do not burn leaves. Fireside Resort will provide an area in the spring for the disposal of leaves. All sites must be spring-cleaned by the Thursday before Memorial Day Weekend.

**11. Parking:** You may park one vehicle at your site. If there is not enough room for your car to park at your Campsite, you will need to park in the gravel lot by campstore or asphalt lot. The vehicles may not hang out into the road or another site or be parked on an empty campsite. Please do not park on empty campsites or other seasonal extra drives. While visiting the swimming pond, please do not park golf cart by gate. Please use designated golf cart parking where available. Vehicles may not be left unattended for more than 3 days.

**12. Pets:** A maximum of two pets per Campsite. All pets must be kept on a leash and under control; noisy or vicious animals are not welcome at Fireside Resort. Pets are not permitted in designated picnic areas or camp buildings. It is your responsibility to clean up after your pets. All Seasonal Campers with dogs are required to fill out a pet registration form. Pets must not be left on a campsite unattended. Excessive barking or aggressive behavior, failure to keep the pet leashed or leaving the pet unattended will give the campground cause to require the pet to be removed from the property. Upon two occurrences of the owner being required to remove the pet, the pet will no longer be permitted to be on campground property.

**13. Playground:** There is a playground next to the swimming pond. Another playground can be found near the large shelter house and the jump pad. Children must be supervised. Please do not use it during quiet hours.

**14. Shade Tents/Screen Room:** You are welcome to set up a free-standing screen room provided it is not attached to the RV or permanent in nature. Your Campsite must have suitable space available. Shade tents/Screen rooms may not be up over 3 days. The maximum size is 12'x12'. Built-on enclosures and porches require a site improvement form to be approved.

**15. Shelter House:** You are welcome to sign up to use the Seasonal area shelter house for 8 hours, cost is \$100 and a limit of 50 people. All visitors need to register at the camp office. To reserve, see the office for a schedule. Vehicles should stay at your Campsite unless dropping items off or picking up. Visitors should park in the asphalt parking lot. Visitors may be charged for any activities the campground is providing for the weekend. Loud and unruly behavior, use of coarse language, and music that is not family appropriate will not be tolerated. These are cause for cancelling your event and removing your guests from the campground. The shelter must be cleaned after use; take the trash to the dumpster located in the asphalt parking lot. Visitors must leave by 10pm.

**16. Site Improvements:** Improvements include but are not limited to decks, patios, sheds, and the like. The Campsite Improvement Request Form Example is at the end of the Seasonal Handbook. Blank forms are available at request at the camp store. Completed forms must be approved before the commencement of any site improvement.

Unauthorised improvements are subject to additional charges and other remedies, up to and including immediate seasonal camping agreement termination with ejection from Fireside Resort without refund.

**17. Storage Shed/ Additional structures:** ONLY 1 shed per site is allowed, pre-approved by Fireside Resort Management. Sheds must be on runners. Campers must be able to come out of a structure built; the structure must be pre-approved by Fireside Resort Management. Sheds must have solid sides; they can NOT exceed 10x10x10. Any electric run to the shed must be pre-approved by Fireside Resort Management. Concrete pads are allowed, but must be pre-approved by Fireside Resort Management, and become the property of Fireside Resort once installed. Wood decks are allowed, and cannot be secured to ground(concrete posts). Deck sections can be no bigger than 8x8, multiple sections can be fastened together. Wood decks must be kept clean and free of mold and mildew. All wood decks must pass an annual inspection by Fireside Resort management. No construction from Friday 3pm - Sunday 12pm. A Campsite Improvement form will need to be approved.

**18. Appliances:** All appliances must be kept inside a shed or RV. No appliances will be allowed outside. A limit of one extra electric appliance is allowed.

**19. Tent:** We do allow 1 tent to be pitched on your campsite. Tents may not be kept up for more than 2 days. Overnight visitors will be charged \$10 a night per person.



20. **Trash:** Dumpsters are provided in the campground. Seasonal campers are responsible for the disposal of their own trash. All trash must be placed in a garbage bag. Any non-trash items, such as but not limited to carpeting, construction materials, paint, furniture, old lawnmowers, or other bulky refuse is your responsibility to remove. A \$150 fee will be assessed to the site account for non-compliance. Reminder seasonals are to use the asphalt dumpster-Especially during Holiday Weekends.

21. **Water:** Approved potable water hoses must be used. (Blue or White). Non-potable (Green) hoses will be removed by management

22. **Washing Your RV:** This is permitted, but please conserve water usage. Please be aware that weekends are high water usage and washing of the RV should be kept to weekdays. If using a pressure washer, please recognize quiet hours and the possibility that the noise or exhaust may be causing discomfort to your neighbor.

23. **Picnic Tables:** Fireside Resort provides 1 picnic table per site for sites 15-78. Wood sites will need to supply their own table. If wanting to stain or paint tables a site improvement form is required.

24. **Commercial Photography:** Commercial photography and filming activities are often conducted at Fireside Resort. You, your relatives, or your guests may appear in resulting photos, films, and videos which may be used in conjunction with advertising or other activities without payment.

25. **Liability:** Fireside Resort is not responsible for any damage or theft to your property on your lot. Fireside Resort is also not responsible for food lost during power outages and circumstances out of our control.

## **Section V**

### **Conduct**

1. **Children:** Parents are responsible for what their children are doing. Accompany your children to the playground, swimming pond, jump pad, and activities. Please take your children with you when you leave property. Do not leave children alone at a campsite. Children under 17 must be on site by 10pm unless with an adult. Any children that are a continual distraction because of their actions, attitude, misbehavior, or lack of regard for the safety of themselves or others will be asked to leave. Should the behavior continue, they will lose all privileges for the remainder of the season. These rules also apply to friends and visitors of registered seasonal guests.

2. **Drones:** Due to the privacy and safety of our guests, we will not allow drones to be flown over Fireside Resort property. Any exception to this policy can be authorized only with the express written consent of Fireside Resort Campground.

**3. Firearms/Weapons:** Pursuant to the Ohio Revised Code. Unless otherwise authorized by law, no person shall knowingly possess, have under the person's control, convey or attempt to convey a deadly weapon or dangerous ordinance onto these premises. No discharge of firearms or loud noise-making devices in the campground.

**4. Fireworks:** Ohio Law prohibits them. All fireworks, sparklers and the like are prohibited.

**5. Quiet Hours 10pm—8am.** This doesn't mean you need to go to bed. However, it does mean that we want the campground quiet, calm, not disrupted by loud voices, music, bright lights, children running around unsupervised or other noisy activities.

**6. Police Presence:** Upon 1 visit by Local Law Enforcement for non-compliance of local, state, or federal laws or campground policy, Fireside Resort reserves the right to eject the Seasonal Camper(s) immediately and without a refund.

**7. Prohibited Items:** Absolutely no illegal drugs in the park. Eviction and law enforcement will result. You are responsible for your guests' behaviour. No fireworks, chinese lanterns, tasers, BB guns, paintball guns, pellet guns, slingshots, or similar devices. No loud audio devices, profanity, or obscenities. No destruction of property or disorderly conduct. No large campfires. Campfires must stay inside the fire ring. Never leave a fire unattended, extinguish before turning in for the night or leaving the campground. The collection of firewood or cutting of trees is strictly prohibited.

## Section VI

### Golf Carts & Vehicles

**ALL VEHICLES PARKED AT CAMPSITE MUST MAINTAIN A MINIMUM OF 24" FROM THE DRIVEWAY.**

**1. Bicycles:** Bike riding after dark is not permitted. Please use bicycle racks where available. No bicycles on the patio, playgrounds or shelter houses.

**2. Golf Carts:** Electric and gas golf carts are allowed. A golf cart registration sticker is required per golf cart. Maximum of 2 golf carts per site. Proof of insurance for each covered driver is required each season to update your file. NO Driver's Licence? NO DRIVING of ANY Motorized Vehicle at any time for any reason. Golf Carts driven after dark must have working headlights and taillights. Reckless driving, failure to remain on the roads, damage to property, or not using proper parking areas will result in revocation of golf cart privileges. All passengers must be seated. Do not park on patios, playgrounds, or under shelter houses. Golf carts should only be driven by the registered owners.

3. **Motorcycles:** Motorcycles may be driven to and from your site but not around the campground.

4. **Mopeds, Scooters, ATVs, and Mini-bikes are prohibited.** Unregistered vehicles and off-road recreational vehicles are not permitted.

5. **RV or Camping Unit:** An RV or camping unit refers to any Recreational Vehicle Industry Association (RVIA) approved RV. Your camping unit must be washed at least once per season to maintain a clean and moss/mold-free appearance. Your camping unit and other accessories (decks, screen porches, and the like) must be in good repair. Photos and proof of model year are required with your application. Approval is at the discretion of management. Management reserves the right not to accept any RV that we feel is not aesthetically pleasing to the Seasonal Campground.

6. **Selling Camper/Site:** We do allow you to sell your site with the camper. Your seasonal agreement can be transferred to another individual. There is a \$100 transfer fee that is the seller's responsibility. The new owner must complete a seasonal application and be approved by Fireside management. Please notify Fireside Management first if selling a site/camper, you must be present for showings. Do not list Site # on listings.

7. **Handbook Violations:** Fireside Resort is a privately owned campground and we reserve the right to select our campers and visitors. Any infraction of the park rules will result in camping privileges being revoked and charges will be applied for any damage. The owners reserve the right to eject without notice or refund any objectionable person who causes a disturbance or becomes a nuisance.

- 1st: Verbal Warning
- 2nd: Written Warning
- 3rd: Termination of camping privileges without a refund.

Depending on the serenity of the violation, a first time Seasonal Camping Handbook violation may be subject to termination of camping privileges.

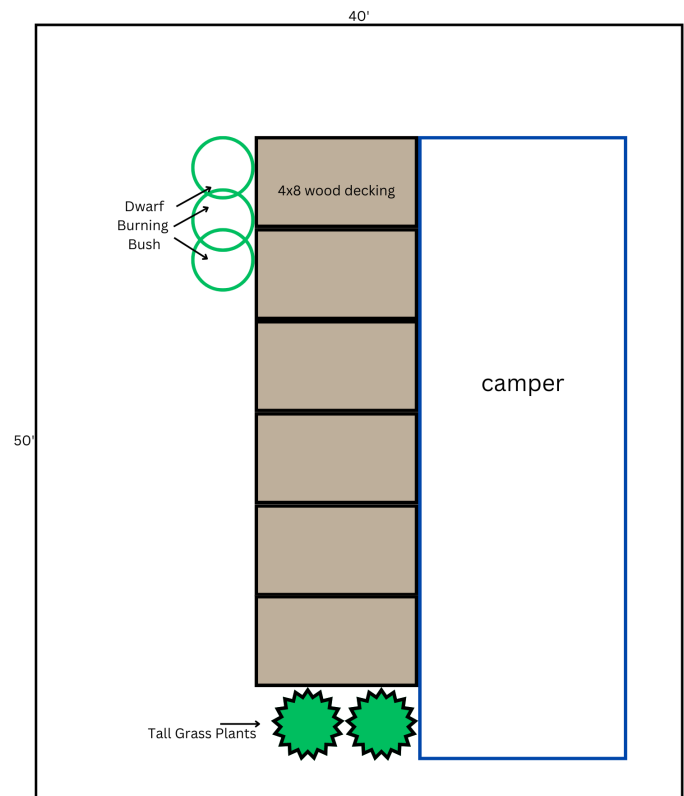
